I understand that my Weekday Pass is **NONTRANSFERABLE** and **NON-REFUNDABLE**. If the pass is altered or used by anyone else, it will be immediately and permanently revoked. A Weekday Pass is valid Monday through Thursday, during normal hours of operation. The pass must be visible to lift operators and management whenever using the lift. A lift ticket must be purchased if the pass is left home. If the pass is lost or stolen, there will be a \$20.00 replacement fee. Once the pass is issued it is the Pass Holder's responsibility to use it as stipulated. The Pass Holder is expected to ski/ride obeying the rules and regulations of the state of PA and Mount Pleasant of Edinboro including meeting all equipment safety requirements.

Warning to Skiers: Skiing and Snowboarding, like many other sports, contains inherent risks including, but not limited to, the risk of personal injury including, catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions, or surface or subsurface snow, ice, bare spots or area of thin cover, moguls, ruts, bumps, or other persons using the facilities: or rocks, forrest growth, debris, branches, trees, stumps: or other natural or man made objects that are incidental to the provision or maintenance of a ski facility in PA. state. PA law imposes a duty on you to become apprised of and understand the risks inherent in skiing, which are set forth above, so that you make an informed decision whether to participate in skiing not withstanding the risks. PA also imposes duties upon you, to which you must adhere for the purpose of avoiding injury caused by any of the risks inherent in skiing. If you are not willing to assume all of these risks and abide by these duties, you must not participate in skiing/snowboarding at this area.
