The Pass Holder is expected to skillride obeying the rules and regulations of the state of PA and Mount Pleasant of Edinboro including meeting all equipment safety requirements. I accept responsibility for the equipment listed on this form in the condition presented to me. I accept full responsibility for it's care while in my possession. I will be responsible for replacement, at full retail value, of any equipment rented from Mount Pleasant's Rental Shop for loss or damage of any kind, other than reasonable wear, which results from the use of the equipment. I agree to return all equipment by the agreed upon time, in clean, undamaged condition to avoid any additional charges. I have made no misrepresentations to Mount Pleasant of Edinboro in regard to my height, weight, age or skiing ability.
