Rules:

- Use good social distancing practices on trails
 - Pass must be worn at all times
- Waiver must be signed and users must sign in and out daily
 - No horses or motorized vehicles
- No air rifles, paintball guns or projectiles of any sorts
 - Walkers have the right-of-way to bikers
 - Dogs must be under control or on a leash
- Please keep all trails and areas around the lodge free of dog waste!
- Please be considerate, do not bike in wet conditions that may deteriorate the hill and trail
 - Be respectful of the hill! Please do not litter!

Recommendations:

- Carry a phone or come with a friend! The hill IS NOT patrolled.
- Have an emergency plan in place! The lodge may not be open.

Waiver:

I understand that there are inherent risks of injury in the sport of walking, running or biking. These risks include but are not limited to, variations in slope, steepness and terrain, trailside drop-offs, rocks, trees, and component parts, and other forms of natural and man-made obstacles or other persons. Slopes vary constantly because of weather changes. Be aware of snowmaking and lift equipment. I further understand that these risks include the risk of personal injury, that walking, running and biking is a DANGEROUS risk sport and that injuries can be serious and even fatal. I HEREBY ACKNOWLEDGE, ACCEPT AND ASSUME ALL RISKS OF INJURY TO ANY PARTS OF THIS USER'S BODY THAT CAN AND DO EXIST IN THE SPORT OF WALKING, RUNNING or BIKING.

I agree that all disputes arising under this contract and/or from any use of the slopes and trails shall be litigated exclusively in the Court of Common Pleas of Erie County, PA, or in the United States District Court for the Western District of PA.

I HEREBY FOREVER RELEASE, HOLD HARMLESS AND INDEMNIFY THE SLOPES AND TRAILS AT MOUNT PLEASANT AND/OR ANY EMPLOYEES THEREOF AS WELL AS THE MANUFACTURERS AND DISTRIBUTORS OF THIS EQUIPMENT FROM ANY LIABILITY OR DAMAGE AND INJURY TO MYSELF OR TO ANY PERSON OR PROPERTY ALLEGEDLY RESULTING FROM THE USE OF THIS EQUIPMENT, ACCEPTING MYSELF THE FULL RESPONSIBILITY OF ANY AND ALL SUCH DAMAGE OR INJURY. I AGREE THAT I WILL NOT SUE MT. PLEASANT OR ITS AGENTS OR EMPLOYEES (EITHER ON MY BEHALF OR ON THE BEHALF OF MY SPOUSE, CHILD OR WARD) FOR INJURIES OR DAMAGES RELATING TO WALKING, RUNNING OR BIKING.
