EVENT AGREEMENT

Parent/guardian ("Responsible Adult") is responsible for the minor _____ (name of minor) and enters into this Agreement regarding the minor's participation in one of the events listed below

Sno Box Derby

In consideration for the minor named above being permitted to participate in the event circled above, Responsible Adult agrees:

To be solely responsible for any medical bills he/she and his/her insurer(s) incurs as a result of treatment provided to minor relating to injuries or death of minor while participating in the event named above, and to release Mount Pleasant of Edinboro, its owners, employees, and agents ("Mt. Pleasant) from liability for medical bills incurred due to the personal injury or death of minor where such personal injury or death arises out of or relates to the negligence Mt. Pleasant, or the risks of the event, as described in paragraph 3, below.

To waive his/her right to sue Mt. Pleasant for damages he/she incurs as the result of personal injury, or death of the minor, including medical bills, or his/her emotional distress, where such damages are caused, in whole or in part, by the negligence of Mt. Pleasant or by the risks of the event, as described in paragraph 3, below.

To review and discuss with the minor the risks listed below. Responsible adult will not permit minor to participate unless responsible adult is satisfied that minor understands and assumes these risks. Responsible adult will use his/her best efforts to ensure that minor understands and acknowledges that one assumed risk common to all events is the negligence of Mt. Pleasant. Responsible adult will explain to minor that it is impractical to list all additional risks in this Agreement. However, Responsible Adult will also explain that the following are examples of risks participants assume:

Sno Box Derby: Inability to maintain control of speed and/or direction; collisions with other participants, spectators, or officials; failure of fencing and other safety equipment or measures; collisions with trees, rocks, stumps, and other forms of forest growth and debris; collisions with poles, fences, towers, and snow making equipment; and falls or collisions caused by bare spots, ice, variation of terrain or of snow conditions, moguls and mounds.

That if a third party sues Mt. Pleasant asserting that he or she sustained a loss resulting from personal injury, death, or property damage, and the third party alleges that his/her loss was the result of the negligence of minor, Responsible Adult will indemnify Mt. Pleasant for any settlement or judgment paid by Mt. Pleasant, and also for attorney's fees and costs incurred by Mt. Pleasant. Responsible Adult also agrees to defend Mt. Pleasant from such claims.

That if, despite the existence of this Agreement, Responsible Adult attempts to sue Mt. Pleasant for his/her own damages, or for minor's damages (acting as minor's representative) arising out of personal injury, death or property damage minor suffered as a result of participating in the event, any such lawsuit must be brought in the Court of Common Pleas of Erie County, PA.
